JIM BUTLER DAYS VENDOR APPLICATION RULES

Submission deadline for your application and payment is May 9, 2025.

All Vendors

- ONLY THE VENDOR APPLICATION IS REQUIRED TO BE SUBMITTED (Pages 2 and 3 only)
- Each 10'x10' space is \$50 for all goods vendors and \$100 for all food vendors. This fee covers all three days of Jim Butler Weekend, May 23-26. If you require a larger space, you must pay for and reserve a second space. Should you wish to open your booth prior Friday, May 23rd, you must pay \$100 per day for each day you are open between Sunday, May 18th and Thursday, May 22nd. No vendors shall be permitted to sell before Sunday, May 18th and after May 26th under the Jim Butler Days event umbrella. -Vendors may be allowed to set up their booths Thursday evening for free if prior notice is given to the Event Coordinator in order to alleviate heavy traffic Friday morning.
- Vendor set-up begins at 7:00 AM Friday morning and ends at 10:00 AM in the Tonopah Event plaza. All vehicles must be removed from the plaza by the required time. It is recommended to unload your vehicle entirely before setting your booth(s) up. Loading space is limited and you may be asked to move your vehicle to allow other vendors to have access.
- The wind is unpredictable in Tonopah, NV, so for the safety of yourself and the people around you we require that you anchor your booth with sandbags or weighted buckets. Please note: Ground stakes are not permitted. Vendors in trailers and food trucks are exempt.
- Power access is very limited for vendors and is distributed on a necessity basis. We highly recommend
 battery-powered lights for the evening. Vendors located in the Event Plaza will have lighting above
 them, but in-booth lighting is still recommended.
- No loud generators will be allowed in the Event Plaza as the noise will interfere with Friday night's Street Dance entertainment. If you have a loud generator we will place you in a secondary location.
- All vendors will receive an email confirmation of their Vendor Application acceptance within a week of submitting your application. All vendors will receive an email no later than Monday, May 19th with a map of Vendor Location Assignments. If you are not happy with your assignment you have up to Thursday, May 22nd to request a refund. A physical map of the Vendor Location Assignments will be posted in the Plaza during the event. Vendors setting up in ANY spot other than the one they were assigned may be asked to leave without a refund.
- Nevada Sales & Use Tax forms will be handed out during the event and are required to be returned to the Event Coordinator prior to departure.

Food Vendors

To avoid competition and repetition we will try not to have multiple food vendors with the same type of food offerings. Food Vendors will be accepted on a first come, first serve basis.

- Food vendors must include a copy of your Temporary Health Permit with your application. No refunds shall be issued to food vendors who fail to receive a proper health permit or fail to pass inspection during the event.
- -Due to the nature of the plaza's new construction, food vendors are required to bring mats to prevent oil spillage on the new concrete.
